Al does not, and will not share in any of the profits generated by the Member or the Co-op Dealership, nor will the Member or Co-op Dealership share in the profits generated by Al.
- 4. CO-OP ARRANGEMENT Member agrees to enter into a "Co-op Arrangement" with other Member(s), effectively sharing the expenses of the Co-op Dealership. The legal Co-op arrangement shall be accomplished via a Limited Liability Company with each Member being legally, financially and otherwise responsible for his/her individual actions and expenses.
- 5. FEDERAL, STATE & LOCAL LAWS Member agrees to conduct themselves within accordance of all Federal, State and Local Laws and/or Rules of Conduct while part of the Dealership.
- 6. UNFORESEEABLE EXPENSES Member agrees to pay for any and all expenses occasioned by the Co-op Dealership due to Member's situation and/or actions. Such expenses may include, but are not limited to; insurance surcharges, legal fees, extra processing costs, etc...
